TERMS AND CONDITIONS

1. This permit must be available for inspection by any law enforcement officer or any authorized agent of the Ashland County Highway Department and must be carried in the vehicle when the haul is being made. The permit is invalid if it is not presented when requested.
2. This permit is good only for the freight or commodity stipulated.
3. This permit is good only for the weight and or load size stipulated in the permit.
4. This permit is good only for the time and date stipulated.
5. This permit is good only for the number of trips stipulated.
6. This permit is good only for the vehicle it is assigned to.
7. This permit is good only for the route stipulated.
8. This permit is good only for the route specified on the Ashland County Trunk Highway System. Permits may be necessary in order to use Town, City or Village streets and roads. This permit is not valid for a posted State Trunk Highway. This permit is not valid outside of Ashland County.
9. Any violations of the terms of this permit or the conditions stated above will be cause for immediate revocation of the permit. Revocation will take place by the holder or vehicle operator being informed in writing or verbally that the permit has been withdrawn.
10. Violation of the terms or conditions of this permit will result in a minimum of 1 year's suspension of any special hauling permits.
11. Special Hauling Permits are granted on a case by case basis and the Ashland County Highway Department has no obligation written or implied to grant such permits. The granting of permits will be at the sole discretion of the Ashland County Highway Commissioner or his designee.
