
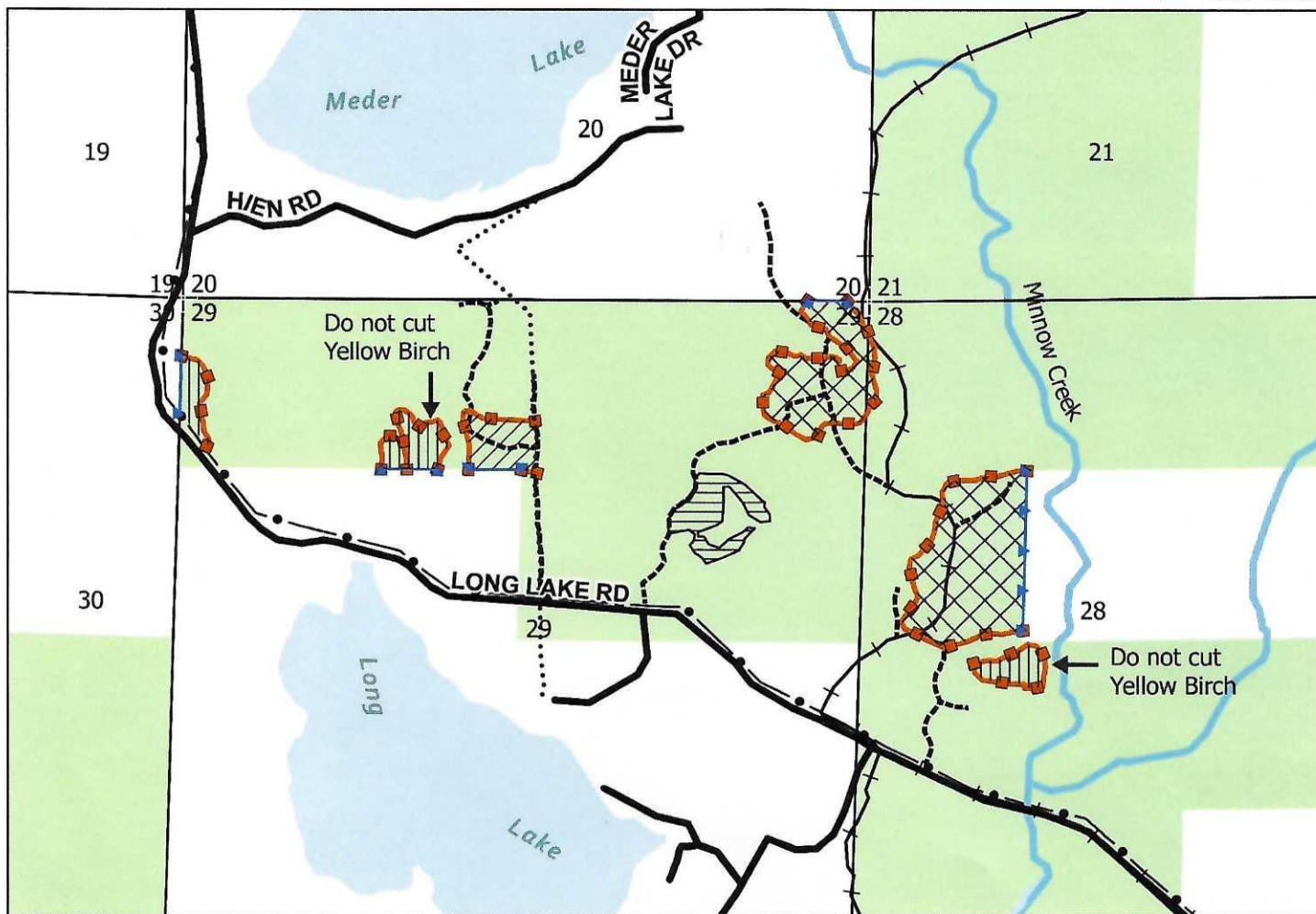




Ashland County Timber Sale

CUTTING SPECIFICATIONS:

















In all units, do not cut hemlock, spruce, oak, or white pine. Do not cut trees marked with purple paint.

-  • **Overstory Removal (Stand 15, 5 acres):** Cut all trees with one or more 100" pulp sticks except reserve species and trees marked with purple paint.
-  • **Shelterwood (Stand 4 & 12, 35 acres):** Cut all trees with one or more 100" pulp sticks except reserve species and trees marked with purple paint. *Avoid canopy gaps where established regeneration exists.*
-  • **Coppice (Stand 10, 13 and 16, 9 acres):** Cut all stems 1" and larger except reserve species and trees marked with purple paint. Cut any balsam fir containing at least two 100" pulp sticks. **YELLOW BIRCH reserve areas are shown on the sale map.**
-  • **Red Pine Thinning (Stand 29, 5 acres):** Cut all red pine, balsam, hardwoods and aspen except reserve species and trees marked with purple paint.

CUTTING RESTRICTIONS:

- Harvesting will be limited to dry summer or frozen ground conditions.
- Excessive rutting or damage to residual trees shall result in the suspension of logging.
- The sale must be cut progressively
- No new woods roads shall be constructed without prior approval of the county forester.
- Care must be taken to preserve survey monuments.
- Care must be taken to not excessively damage existing saplings and residual trees.
- Berm roads when sale is not active and upon completion.
- Snag and den trees should be left standing if they don't pose a safety hazard.
